**ARTICLES OF INCORPORATION
of
BONDATA GROUP LIMITED, INC.**

Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned incorporators submit these Articles of Incorporation for the purpose of forming a for-profit corporation.

Article 1. The name of the Corporation is BonData Group Limited, Inc.

Article 2. The principal place of business of this corporation is 1089 Brevity Lane, Fort Myers, Florida. The mailing address of this corporation is Post Office Box 1713, Fort Myers, Florida 33902-1713.

Article 3. The corporation is authorized to issue two classes of stock, that being 10,000 shares of no par value, Class A Common stock, and 10,000 shares of Preferred Stock, \$100 par value, with identical rights and privileges for each class, the transfer of which is restricted according to the bylaws of the corporation.

Article 4. The name and address of the corporation's initial registered agent is: Randall Wayne Burnley, 1089 Brevity Lane, Fort Myers, Florida.





