This undersigned, for the purpose of forming a corperation under the Florida General Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

ARTICLE 1

NAME

The name of the corporation is $Incos_{j}$ Inc.

DURATION

This corporation shall exist perpetually.
