ARTICLES OF INCORPORATION OF MARK E. GOLDSTEIN, P.A.

The undersigned natural persons, each of who is licensed or otherwise legally authorized to practice the profession of real estate sales and leasing in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such Corporation:

FIRST: The name of this Corporation is MARK E. GOLDSTEIN, P.A.

SECOND: This Corporation is organized for the purposes:

- a) To engage in the practice of real estate; and to engage in the sale, lease, management, consulting, evaluation of real estate as a professional corporation and to carry on services incident thereto. The practice of real estate as stated herein is the sole and exclusive professional service to be rendered by this Corporation.
- b) To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this Corporation.
- The professional services of this Corporation shall be carried out only through officers, employees, and agents, each of whom is a licensed real estate salesperson, and is duly authorized to sell and lease real estate in the State of Florida.
- THIRD: The period of the Corporation's duration shall be perpetual or until dissolved by a vote of the shareholders as hereafter provided.
- FOURTH: This Corporation is authorized to issue 1000 Shares. Such shares shall be of a single class of common stock, and shall have a par value of \$1.00 per share.
- FIFTH: The address of the principal office of this Corporation is 2665 South Bayshore Drive, Suite 1002, Miami, Florida 33133.
- SIXTH: The Corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.
- SEVENTH: The name of the Registered Agent of this Corporation is MARK E. GOLDSTEIN, 2665 South Bayshore Drive, Suite 1002, Miami, Florida 33133.

The Corporation is to managed by a Board of Directors. The number of directors constituting the initial Board of Directors is one (1), MARK E. GOLDSTEIN, 2665 South Bayshore Drive, Suite 1002, Miami, Florida 33133. The initial directors shall hold office until their successors are elected and qualified as provided in the By-laws. Thereafter, the terms of office of each director shall be one (1) year and until the election and qualification of a successor. The number of directors set forth herein and constituting the initial Board of Directors shall be the authorized number of directors until such number is changed by a By-law duly adopted by the shareholders.

NINTH: The initial directors shall submit the proposed By-laws to the shareholders at a meeting to be held for that purpose not more than 30 days following the issuance of the Certificate of Incorporation. Following the adoption of By-laws by the affirmative vote of a majority of the shareholders, the internal affairs of the Corporation are to be regulated and managed in accordance with such By-laws.

TENTH: The Corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least 2/3 of the outstanding shares of the Corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the Corporation, be distributed to the shareholders prorata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.
