ARTICLES OF INCORPORATION

CHUCKIE'S CHICKEN, INC. EFFECTIVE DATE

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida

ARTICLE I
