

# ARTICLES OF INCORPORATION OF

Motorrad-Rennsport U.S.A., Inc.



### ARTICLE I Corporate Name

The name of this corporation is: Motorrad-Rennsport U.S.A., Inc..

## **ARTICLE II Nature Of Business And Powers**
