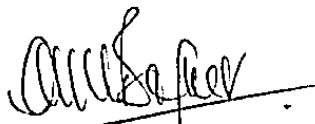

Articles of Incorporation
of

The undersigned subscribers, natural persons acting as Incorporators for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following Articles of Incorporation:

Article One Name

The name of the Corporation shall be: American A-Sue Corporation

Article Two Duration

The term of existence of this Corporation shall be perpetual and shall commence effective immediately.

Article Three Purpose

The purpose for which this Corporation is organized is to engage in and transact any and all lawful business for which corporations may be permitted under the laws of the State of Florida and in all other States and Countries.

Article Four Capital Stock

The maximum number of shares of authorized capital stock of this Corporation shall be Ten Thousand (10,000) shares of common stock having a par value of Fifty Dollars (\$50.00) per share.

Ten (10) shares of common stock shall be issued at this time and the remaining Nine Thousand, Nine Hundred Ninety (9,990) shall be held in the Corporation. There shall be only one class of stock.

Every shareholder, upon the sale for cash of any new stock of this Corporation, shall have the pre-emptive right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) prior to it being offered to others. Shares shall be restricted and shall not be offered to others without a majority vote and approval by the Board of Directors.

The capital stock shall be paid in cash, and accepted as approved by the Directors at the Organizational Meeting, or at a meeting called for such purpose.

Article Five Initial Capital

The amount of capital with which this Corporation may begin business shall not be less than Five Hundred Dollars (\$500.00).

Article Six Registered Office
