WE, the undersigned subscriber (s) of these Articles of Incorporation and a natural person competent to contract, hereby associate ourselves together to form a corporation under the laws of the State of Florida.

ARTICLE I.

PAME

The mane of this corporation shall be ANTOINE'S SALON, INC.

AMPICIA II.

NATURE OF PUBLISHEDS

The general nature of business to be transacted by this corporation is:

- (a) Beauty Salon . Hair cutting, hair styling, manicures, pedicoures.
- (b) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pladge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandles, real and personal property, and services of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone or cometery company, a building and loss association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
- (c) To conduct business in, have one or more offices in, and buy, hold, mortgage, soil, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.

- (4) To contract debta and borrow noney, issue and sell or pledge tonia, detentures, notes and other evidence of indebtedness, and execute such nortgages, transfers of corporate property, or other instruments to accure payment of corporate indebtedness as required.
- (*) To purcious the corporate assets of any other corporation and suggest in the same or other character of business.
- (f) To guarantee, endome, purchase, hold, sell, transfer, mortgage, pludge or otherwise acquire or dispose of the shares of the capital stock of, or any homis, securities, or other evidence of indebtodness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- (g) To carry on any lawful buniness necessary or incidental to the attniment of the objects of the corporation whether or not such buniness is similar in nature to the objects enumerated herein.

ANTICLE 111.

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares at \$1.00 per value, per share.

Sharen of stock of this corporation shall be paid for in each at a valuation to be fixed by the affirmative vote of the majority of the Board of Directors, but may be paid for by property, labor of services, whenever the Board of Directors so authorizes.

The amount of capital with which this corporation shall begin business is at least \$500.00. The proceeds of stock will be for at least as much as the amount necessary to begin business. After business has begun, the corporation shall have perpetual existence.
