ARTICLE I - NAME

The name of this corporation is BREVARD BONDING, INC.
The principal address of this corporation is 310 Brunson
Blvd. Cocoa, Florida 32922.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date
of commencement of the corporation shall be May 1, 1995.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of
engaging in any business activity permitted under the laws
of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of
\$1.00 par value common stock.

ARTICLE XII - AMENDMENT

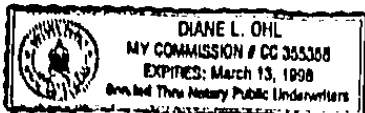
