ARTICLES OF INCORPORATION OF MOM'S OTHER TAXI, INC.

ARTICLE I - CORPORATE NAME/ADDRESS: The name of this corporation shall be MOM'S OTHER TAXI, INC. and the address of the principal office and of the corporation shall be 1200 10th Pl, Vero Beach, Florida 32960 and the mailing address is the same.

ARTICLE II - REGISTERED OFFICE/AGENT: The corporation's initial registered office shall have a street address of 2186 34th Ave., Vero Beach, Florida 32960 and the mailing address is the same. The initial registered agent at that office is DONNA J. WADDELL .

ARTICLE III - PURPOSE: The purpose of this corporation is TRANSPORTATION of minor children, and any an all other lawful purposes for which corporations may be organized.

ARTICLE IV - INCORPORATOR: The incorporator of this corporation is DONNA J. WADDELL, 2186 34th Ave., Vero Beach, Florida 32960.


ARTICLE V - DIRECTORS/OFFICERS: There shall three initial directors DONNA J. WADDELL, 2186 34th Ave., Vero Beach, Florida 32960, who shall also be President; BRENDA T. BROWN, who shall also be Vice President, 2344 SR 1st Ave., Vero Beach, Florida 32962; and PAMELA WADDELL, 1200 10th Pl, Vero Beach, Florida 32962, who shall also be Secretary and Treasurer, of this corporation.

ARTICLE VI - SHARES OF STOCK: This corporation shall be authorized, initially to issue 100 shares of common stock at \$1 par value.

This Article may be amended by bylaws or shareholder agreement without amending these Articles.
