# ARTICLES OF INCORPORATION OF BUSY BLADES LAWN SERVICE. INC.

#### ARTICLE I CORPORATE NAME

The name of this corporation is Busy Blades Lawn Service, Inc.

#### ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of this business is lawn care and landscape.

#### ARTICLE III. CAPITAL STOCK
