ARTICLE I. CORPORATE NAME

The name of this corporation is Busy Blades Lawn Service, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of this business is lawn care and landscape.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding any one time is Five Hundred (500) shares of capital stock having a par value of One Dollar (\$1.00) per share, capital stock shall be the only class of stock this corporation shall have the authority to issue.
