

ARTICLES OF INCORPORATION  
OF  
MEDICAL BILLING NETWORK, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Medical Billing Network, Inc. The principal office of the corporation is 10303 Night Wind Circle, Cantonment, FL 32533.

ARTICLE II - DURATION

The duration of this corporation is perpetual.

ARTICLE III - PURPOSE

The general purposes for which this corporation is organized are:
