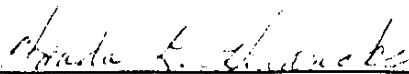
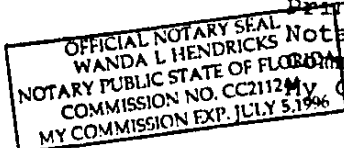
XI. AMENDMENTS
