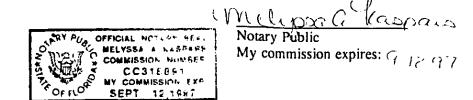

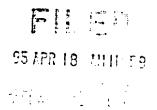
ARTICLE NINE AMENDMENT OF ARTICLES
