The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

# ARTICLE I CORPORATE NAME AND PRINCIPAL OFFICE

## ARTICLE II NATURE OF CORPORATE BUSINESS

The Corporation may engage in or transact any or all activity or business permitted under the laws of the United States and of the State of Florida.

The Cuporation shall have a perpetual existence, unless sooner dissolved according to law.
