**ARTICLES OF INCORPORATION  
OF**

**PAMELA WILSON, INC.**

We, the undersigned, acting as Incorporator (s), desiring to form a corporation for profit pursuant to the Florida Business Act, adopt (s) the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME**

The name of this corporation is PAMELA WILSON, INC.

**ARTICLE II - DURATION**

This corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually unless dissolved by operation of law.

**ARTICLE III - GENERAL PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business authorized and not prohibited by the Florida Business Corporation Act, as the same may be from time to time amended.

**ARTICLE IV - CAPITAL STOCK**
