I received your letter dated November 15, 2002 last week and I hasten to reply.

I am resubmitting the above referenced report, which I originally sent on November 1, 2002. Thank you for pointing out that the change of address should be completed in sections 2 and 3. This information has now been entered.

With respect to the imposition of additional amounts to reinstate this corporation I respectfully request your reconsideration. Please note that I took over this business from my husband who died at the end of last year. I closed up the office and issued a change of address form to the Post Office. Having not previously worked in this business I did not know what to expect. Apparently it takes quite a bit of time for change of address mail to go from one address to another.

I was quite surprised when I received this report form during the week beginning Monday, September 16 right after the Yom Kippur holiday, only to see that the report was apparently due not later than September 13. As I had no knowledge of the existence of this report till then, I don't think it is reasonable to penalize me for not filing the return till after the September 13 due date.

Therefore I respectfully request your reconsideration of the imposition of penalties and request that this corporation be reinstated without penalty.
