ARTICLES OF INCORPORATION
OF
SWEET HOME COUNTRY MANOR, INC.

The undersigned, acting as incorporator to these Articles of Incorporation, hereby form a corporation under the laws of the State of Florida.

ARTICLE I
NAME AND ADDRESS

The name of the corporation is: Sweet Home Country Manor, Inc.. The physical address of the corporation is 6405 - 40th Avenue North, St. Petersburg, Florida 33709. The mailing address of the corporation is 3200 - 60th Street North, St. Petersburg, Florida 33710.

ARTICLE II
NATURE OF BUSINESS

The purpose of this corporation is to engage in any activities or businesses permitted under the laws of the United States and the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The corporation is authorized to issue seven thousand five hundred (7,500) shares, all of one class, at a par value of One Dollar (\$1.00) per share.

ARTICLE IV
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI

DATE OF INCEPTION**

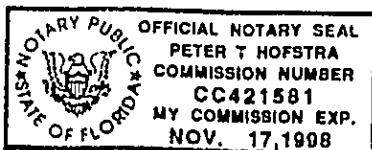
The date the corporate existence shall begin is as of the date of filing and acceptance of these Articles by the Secretary of State of Florida.
