

The undersigned, acting as incorporators of a professional service corporation under the Florida Professional Service Corporation Act, Chapter 621, Florida Statutes (1979), adopt the following Articles of Incorporation for such Corporation:

ARTICLE I. NAME

The name of this Corporation is SASSER & RIZK, P.A.

ARTICLE II. TERM OF EXISTENCE

This Corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

The purpose for which the Corporation is organized are:

(a) To engage in every phase and aspect of the business of rendering the same professional services that an attorney, duly licensed under the laws of the State of Florida, is authorized to render; provided, that such professional services shall be rendered only through officers, employees, and duly authorized agents of the Corporation who are licensed under the laws of the State of Florida to practice law therein.

(b) To do everything necessary and proper to accomplish or further any of the purposes or to attain any of the objects, enumerated in these Articles of Incorporation or any amendment thereof and everything necessary or incidental to protect and benefit the Corporation -- whether alone or in association with other corporations, firms or individuals.

The foregoing paragraphs shall be construed as enumerating

both objects and purposes of the Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

ARTICLE IV. CAPITAL STOCK

The number of shares of stock which the Corporation shall have authority to issue is Five Hundred (500) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V. ADDRESS

The address of the initial registered office of the Corporation is Suite 102, 1717 Blanding Boulevard, Jacksonville, Florida 32210, and the name of its initial registered agent at such address is Roger W. Rizk. The principal address and the registered office address are the same.

ARTICLE VI. DIRECTORS

The number of directors constituting the initial Board of Directors of the Corporation is two, and the name and address of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
