We the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privi ges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be: ' BAR C INC.

ARTICLE III

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things hereinafter mentioned as freely and to the same extent as natural person might or could do, to-wit:

To engage in various enterprises for profit, including the organization, promition, and conducting of professional rodeo events, including such activities to support the activity such as but not limited to, dealing with livestock and horses; advertising,

promotions, and using or acquiring such goods and services as would support the events; obtaining insurance; hiring or retaining employees or independent contractors; borrowing money; or any other act necessary to conduct the business; and also, such additional functions reasonably calculated as appropriate to carry on the general nature of the business.

ARTICLE IV

The amount of capital stock of this corporation shall be one hundred (100) authorized shares of \$1.00 par value.




