ARTICLES OF INCORPORATION
OF

ARTICLE I
CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS

The name of this Corporation shall be: *M & M MAINTENANCE OF VOLUSIA COUNTY, INC.*, with its principal office located at 314 Goodall, Apt. "C", Daytona Beach, Florida 32118 and its corporate mailing address being the same.

ARTICLE II
NATURE OF BUSINESS AND POWER

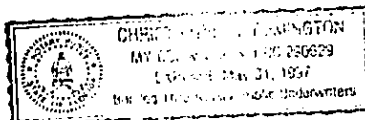
