

ARTICLES OF INCORPORATION

OF

M & M MAINTENANCE OF VOLUSIA COUNTY, INC.

ARTICLE I CORPORATE NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this Corporation shall be: M & M MAINTENANCE OF VOLUSIA COUNTY, INC., with its principal office located at 314 Goodall, Apt. "C", Daytona Beach, Florida 32118 and its corporate mailing address being the same.

ARTICIEII NATURE OF BUSINESS AND POWER

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share.
