We never received an initial notice, which according to your 2nd Notice Form indicates that we should have received earlier this year.

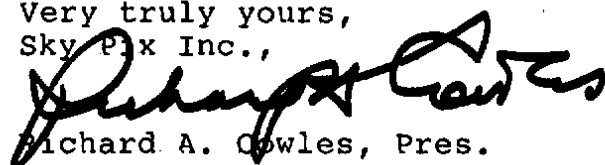
