The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I - NAME

The name of this corporation is CARE & CURE CENTRE, INC.

ARTICLE II - TERM OF EXISTENCE
