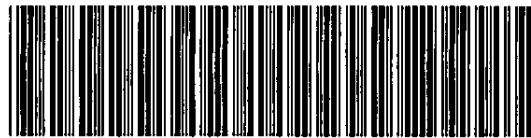

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation prior to effecting any changes contemplated by these Articles of Amendment is 1 Nation Technology Corp. and its Document Number is P95000030500.

2. Article I of the Articles of Incorporation of the Corporation is amended as follows:

"The name of the corporation is Skymad Technology Corporation."
