amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

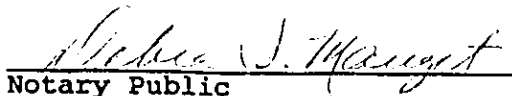

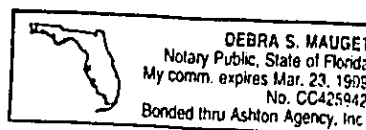
