The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is : LEASEWAY DEPOT, INC.


ARTICLE XI: INDEMNIFICATION


