The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I**

The name of the corporation shall be:  
ATLANTIC FUNDING & FINANCIAL SERVICES, INC.

**ARTICLE II**

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

**ARTICLE III**

The Corporation may engage in any and all businesses and activities permitted by the laws of the State of Florida. The Corporation shall have all of the powers vested in a Corporation organized under and existing by virtue of such laws.

**ARTICLE IV**

The maximum number of share which the Corporation shall have authority to issue shall be 100,000 share of common stock with a par value of \$1.00 per share.

**ARTICLE V**

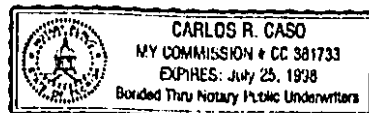
