ARTICLES OF INCORPORATION  
OF

ARTICLE 1. - NAME

The name of the corporation is JFJ ENTERPRISES, INC.

ARTICLE 11. - AMENDMENT

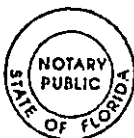
