ARTICLES OF INCORPORATION

TO: SECRETARY OF STATE, STATE OF FLORIDA, TALLAHASSEE, FLORIDA

WE, the undersigned natural person of the age of twenty-one or more, acting as incorporator of a corporation under title 607.164, of the LAWS of the State of Florida, adopt the following Articles of Incorporation for such corporation.

1. *The name of the corporation, hereinafter referred to as the Corporation, shall be
Training Institute of Florida Corporation*
2. *The duration of the Corporation shall be perpetual.*
3. *The object and purpose for which the Corporation is formed is to engage in the business
of a Vocational School and any other business permitted by law.*
4. *The aggregate number of shares which the Corporation is initially authorized to issue is
one thousand (1000). There shall be one class of stock with a par value of \$1.00. There
shall be no preferences, qualifications, limitations, restrictions or special rights with
respect to the one class of stock.*

5. *Shareholder have the pre-emptive right to acquire additional shares of stock.*
6. *Provisions for the regulation of the internal affairs of the Corporation are contained in the By-Laws of the Corporation.*
7. *The Corporation will not commence business until at least one thousand dollars (\$1,000) has been received by it as consideration for the issuance of shares.*
8. *The initial registered office and principal place of the Corporation shall be located at: 4423 Alton Road, Miami, FL 33140. The initial registered agent is Miguel N. Alfie & Rebeca Alfie.*
9. *The following persons shall constitute the initial Board of Directors of the Corporation, and shall serve until the first annual meeting, or until, their successors shall be elected: Miguel N. Alfie, whom resides at 4423 Alton Road, Miami Beach, FL 33140 and Rebeca Alfie, whom resides at 4423 Alton Road, Miami Beach, FL 33140.*
10. *The incorporators of this corporation are Miguel N. Alfie and Rebeca Alfie, whom resides at the address stated in Paragraph 9.*

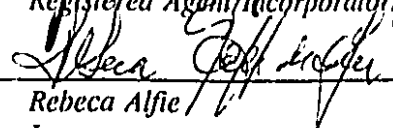
11. The Articles of Incorporation shall constitute a binding agreement and may be amended by the affirmative vote of majority of the Board of Directors in Office.

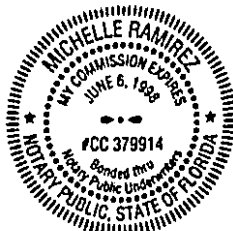
