ARTICLES OF INCORPORATION

OF

DENISSE HEALTH CARE CENTER, INC.

ARTICLE I - NAME

The name of this corporation is DENISSE HEALTIC GARE, CENTER, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE III - ADDRESS
