The undersigned natural person, competent and licensed to practice law in the State of Florida, acting hereby an incorporator for the purpose of forming a Professional Service Corporation of profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I NAME OF CORPORATION

The name of the corporation shall be ARTHUR J. RANSON, III, P.A. The principal office shall be 201 East Pine Street, Suite 425, Orlando, Florida 32801.

ARTICLE II PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of law and all its fields of specializations, as are engaged in by Arthur J. Ranson, III.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be Architects in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- d. To engage in no other business other than the rendition of the professional services specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be One Hundred, (100) shares of common stock at Dollars (\$5.00) per share par value.

ARTICLE VIII INFORMAL SHAREHOLDER ACTION

Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

SEVERANCE AND TERMINATION OF EMPLOYMENT
