WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

### ARTICLE I NAME

This corporation may elect to become a Sub-Chapter S Corporation as defined byu the Internal Revenue Code.


