ARTICLES OF INCORPORATION
OF

BILL'S CUSTOM SHEETMETAL INCORPORATED

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
NAME

The name of the corporation is: BILL'S CUSTOM SHEETMETAL INCORPORATED.

ARTICLE II
CORPORATE PURPOSE AND POWERS

This corporation is initially organized for the operation of any or all lawful business purposes for which corporations may be incorporated under Chapter 607 of the Florida Statutes. This Corporation shall have all corporate powers enumerated in said Chapter 607.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized is one thousand (100) shares of common stock having a nominal par value of One Dollar (1.00) per share, which such stock shall have the entire voting powers of the Corporation.

ARTICLE IV
REGISTERED AGENT/REGISTERED OFFICE

The registered office of the Corporation shall be Bill's Custom Sheetmetal, Incorporated, 361 Coral Drive, Fort Walton Beach, Florida 32548, and the initial registered agent at that address shall be William J. Wernet.



AMENDMENT


