ARTICLE I--NAME

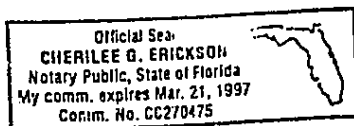


