THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE 1

The name of the corporation is: R G O, Inc.

ARTICLE 11

The general nature of the business to be transacted by this corporation is: to manufacture, purchase, or otherwise acquire and hold, to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph or cemetery association, a cooperative association, fraternal benefit society, state fair or exposition, a building and loan association, or a mutual fire insurance association.

ARTICLE 111

The amount of capital stock authorized is one hundred (100) shares at the par value of Ten Dollars (\$10.00) each, which is the maximum number of shares that the corporation is authorized to issue.

ARTICLE 1V

The amount of capital with which this corporation will begin business with is not less than \$1000.00.

ARTICLE V

The corporation is to have perpetual existence.

ARTICLE VI

The street address of the initial registered office of the corporation is: R G O, Inc. 7492 Malibu Crescent, Boca Raton, Florida 33433, or at such other place within the state as the Board of Directors from time to time by appropriate action, shall determine. 
ARTICLE IX




