ARTICLES OF INCORPORATION
ARTICLE ONE

J. S. WELDING SERVICE REPAIR CORP.

The name of this corporation is: J. S. WELDING SERVICE REPAIR CORP.

The principal office and mailing address of this corporation is: 1840 WEST -
49TH STREET - STE. #605, HIALEAH, FL. 33012

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted ---
under the laws of the United States of America an the laws of the ----
State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissol--
ved in accordance with the laws of the State of Florida. The date on -
which corporate existence shall begin is: UPON APPROVAL BY SECRETARY -
OF STATE.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- A- Designation. The stock of this corporation shall be known as -
Common Stock.
- B- Authorized. The maximum number of shares of Common Stock that
this corporation may issue is 100.
- C- Par Value. Each share of Common Stock shall have the par value
of \$1.00.
- D- Consideration. Shares of Common Stock may be issued in exchange
for cash, real property, labor or services rendered, or any ---
combination of the foregoing. In the absence of fraud in the -
transaction, the judgement of the Board of Directors as to the
value of any such consideration shall be conclusive.
- E- Non-assessability. Each share of Common Stock shall be issued
in exchange for consideration which is at least equal to the --
par value thereof, and shall be fully paid and non-assessable.
- F- Voting Rights. Each share of Common Stock shall entitle the --
record holder thereof to one vote upon each proposal presented
at meetings of the stockholders of the corporation.

- G- Dividends. Record holders of Common Stock are entitled to receive their pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.
- H- Liquidation Rights. Holders of Common Stock are entitled, in the event of the liquidation or dissolution of this corporation to receive their pro-rata share of any assets of this corporation remaining after payment of all corporate debts and obligations.

ARTICLE FIVE

INITIAL REGISTERED OFFICE AND AGENT

The Street Address of the Initial Registered Office of this corporation is 1840 WEST 49 STREET-STE.#605, HIALEAH, FL. 33012 and the name of the Initial Registered Agent of this corporation at that address is JOSE L. CORRALES.

ARTICLE SIX

INITIAL BOARD OF DIRECTORS

This corporation shall have initially one Director. The number of Directors may be either increased or decreased from time to time by the By-Laws but shall never be less than one. The names and addresses of the Initial Director of this corporation is:

ARTICLE SEVEN

BY LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested --- either in the Board of Directors or the Shareholders, but the Board of Directors may not amend or repeal any By-Law adopted by shareholders - if the shareholders specifically provide such By-Law not subject to -- amendment or repeal by the Directors.

ARTICLE EIGHT

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this -- corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the - price at which it is offered by others.

ARTICLE NINE

SHAREHOLDER QUORUM AND VOTING

51% of the shares entitled to vote, represented in person by proxy, -- shall constitute a quorum at a meeting of shareholders.

If a quorum is present, the affirmative vote of 51% of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

ARTICLE TEN

APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of the shareholders of this corporation to any plan of -- merger shall be required in every case, whether or not such approval - is required by law.

ARTICLE ELEVEN

DIRECTOR QUORUM AND VOTING

The majority of the Directors shall constitute a quorum for a meeting of Directors.

If a quorum is present, the affirmative vote of THE MAJORITY of the -- Directors present, or, if a Director of Directors have abstained from voting because of an interest in the matter to be voted upon, the -- affirmative vote of THE MAJORITY of the Directors present and voting, shall be the act of the Board of Directors.

ARTICLE TWELVE

INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.



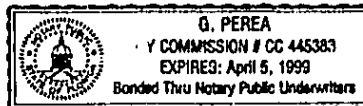
