ARTICLES OF INCORPORATION ARTICLE ONE

J. S. WELDING SERVICE REPAIR CORP.

The name of this corporation is: J. S. WELDING SERVICE REPAIR CORE

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted --- under the laws of the United States of America an the laws of the ---- state of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- A- Designation. The stock of this corporation shall be known as Common Stock.

The approval of the shareholders of this corporation to any plan of -merger shall be required in every case, whether or not such approval is required by law.


