ARTICLES OF INCORPORATION
OF
Leonard/Hackler Development, Inc.

Article I - Name

The name of the corporation is: Leonard/Hackler Development, Inc.

Article II - Duration

This corporation shall exist perpetually.

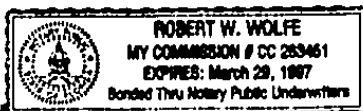
