ARTICLE I

Name

The Name of this Corporation is CLOUD PAINTING, INC.

ARTICLE II

Duration

This corporation shall have perpetual existence commencing on May 1, 1995.

ARTICLE III

Purpose

The general nature of the business and the object and purposes to be transacted, promoted or carried on by CLOUD PAINTING, INC. are as follows:

(a) To engage in any activity or business permitted under the laws of the United States and the State of Florida; and

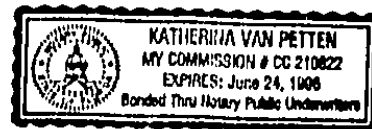
