CERTIFICATE OF INCORPORATION

OF

FIRST: The name of this corporation is JA DE CLUB, INC.

SECOND: Its registered office in the State of Florida is to be located at 12535 Hobson Simmons Road in the City of Lithia, Florida, Hillsborough County, 33547. The registered agent in charge thereof is Deborah Kelley at the same address. The principal place of business will be 1118 C.R. THIRD: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:
