The undersigned, desiring to form a corporation under the laws of the State of Florida, hereby certifies as follows:

FIRST: The name of the corporation is Ben H. Harned Investments, Inc.

SECOND: The corporate existence of the corporation shall commence on April 1, 1995.

THIRD: The purpose for which the corporation has been formed is as follows: to engage in and transact any or all lawful business for which a corporation may be incorporated under Chapter 607 of the Florida Statutes.


