# ARTICLES OF INCORPORATION

- 1 The name of the corporation is:  
**Soft Tissue Rehabilitation Center, Inc.**
- 2 Principal address: 2613 W. 23rd St., Panama City, FL 32405  
The purpose for which this corporation is organized is to provide health care services, to provide patient education, to provide training in Soft Tissue Rehabilitation, and to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.
- 3 The corporation shall have the authority to issue 1,000,000 shares of common stock, in one class only, each with a par value of \$ 0.01.
- 4 The registered agent shall be Robert Allen Doyle and the initial registered office shall be at 3138 E. Game Farm Rd., Panama City, Florida, 32405.
- 5 The initial Board of Directors shall have 2 members whose name and addresses are as follows:

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.
