Pursuant to the provision of Section 621.13, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

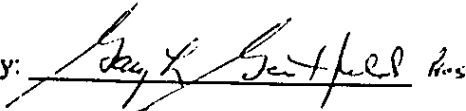
Article One
