# ARTICLES OF INCORPORATION

## Elegance by Marci Cosmetics. Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 6072 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

# ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is Elegance by Marci Cosmetics, Inc., hereinafter referred to as the "Corporation".
