OF

ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - DURATION

The corporation shall exist perpetually commencing
on the date of filing.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of
transaction any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares
of \$1.00 par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any
new stock of this corporation of the same kind, class or
series as that which he already holds, shall have the right
