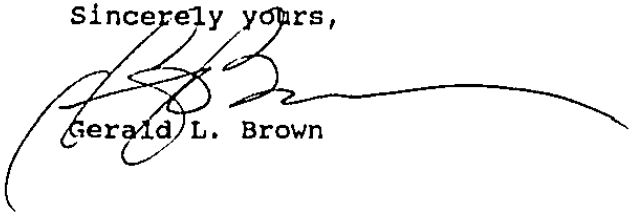

OF
ARCH-TEK, INC.**

ARTICLE ONE - NAME

The name of the corporation is ARCH-TEK, INC.

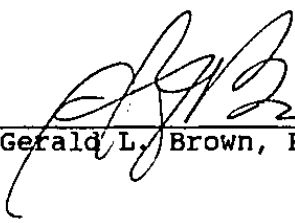
