## ARTICLES OF INCORPORATION

OF

## RASY BUSINESS SYSTEMS II, INC.

## ARTICLE I

The name of this corporation is EASY BUSINESS SYSTEMS II, INC.

## ARTICLE II

This corporation shall have a perpetual existence, unless sooner dissolved according to law.

## ARTICLE\_III

This corporation is organized for the following general purpose: to transact any lawful business for which corporations may be organized under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
