# ARTICLES OF INCORPORATION OF PAXSON ST. LOUIS LICENSE, INC.



The undersigned, acting as incorporator of PAXSON ST. LOUIS LICENSE, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME
