ARTICLES OF INCORPORATION

OF

BLOT ENTERPRISES, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE_I - NAME

The name of the corporation is BLOT ENTERPRISES, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose and nature of business to be transacted by the corporation is as follows:
